ORDER:

The writ petition is filed seeking a Writ of Mandamus to declare the inaction of respondent No.2 in not considering the petitioner's representation dated 02.03.2026 for removal of land in Sy.No.22/C1/2/2, admeasuring Ac.2.00 guntas, Manchuppala Village, Palakurthy Mandal, Jangaon District, from the prohibited list, as illegal, arbitrary and violative of Articles 14 and 21 of the Constitution of India.

2. Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue.

3. Learned counsel for the petitioner submitted that the petitioner filed a suit, O.S.No.943 of 2021, wherein order dated

08.11.2022 was passed in IA.No.1347 of 2021 granting temporary injunction in respect of the subject property and thus, the question of inclusion of the subject property in the prohibited list does not arise.

4. As an innocuous relief is sought for by the petitioner, without entering into the merits of the case, the writ petition is disposed of with a direction to the respondents No.2 and 3 to consider the representation of the petitioner dated 02.03.2026 for removal of land in Sy.No.22/C1/2/2, admeasuring Ac.2.00 guntas, Manchuppala Village, Palakurthy Mandal, Jangaon District, from the prohibited list in the Dharani Portal by taking note of order dated 08.11.2022 in IA.No.1347 of 2021 in O.S.No.943 of 2021 on the file of the Principal Junior Civil Judge – cum – Judicial Magistrate of First Class, Jangaon, by issuing notice to the petitioner, defendants in O.S.No.943 of 2021 and other interested persons, within a period of four (4) weeks from the date of receipt of a copy of this order.

The miscellaneous applications, pending if any, shall stand closed. There shall be no order as costs.

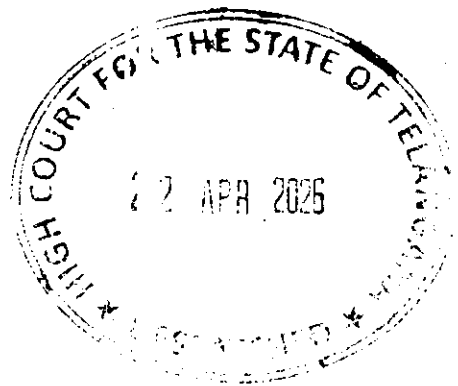
