WHEREAS the Petitioner above named through his Advocate SRI NAYAKAWADI RAMESH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of Writ of MANDAMUS to declare the Proc.No.A4/ 1770/24-II dated. 04.02.2025 of the 4th respondent wherein rejecting the claim of the petitioner to retire him from service in terms of G.O.Ms.No.81 Revenue (Services-II) Department dated 24.07.2023 by sending him to appropriate medical board for determination of his age and to consider the claim of his daughter for appointment to any one of suitable post and not releasing his salary from the month of August 2023 is illegal arbitrary and unconstitutional with a consequential direction to the respondents to consider the claim of the petitioner to retire him from service by sending him to appropriate medical board for determination of his age and to consider the claim of his daughter for appointment to any one of suitable post in terms of G.O.Ms.No.81

Revenue (Services-II) Department dated 24.07.2023 and to release salary from the month of August 2023 with all consequential benefits in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri NAYAKAWADI RAMESH Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
