Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondent Authorities not to alter/delete the name of the petitioner for the subject lands in Sy.No.11-A, 11-B and 11-C of Raimakalakunta village, Manopad mandal, Jogulamba Gadwal District in the related Revenue Records after suspending the operation of impugned orders issued by the 2nd Respondent and continue the name of the petitioner in the subject lands, pending disposal of WP No. 12129 of 2019, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Prima facie, the impugned order passed by the 2nd respondent does not appear to be correct, since he has glossed over the absence of notice to the petitioner while regularizing the unregistered sale deed of 1979 relied on by the respondents 5 and 6 by the 4th respondent, particularly when there is a finding of the 3rd respondent about the lack of evidence about issuance of notice to interested persons. Therefore, there shall be interim suspension of the proceedings D1/31/2011 dt.30.03.2019 of the 2nd respondent.
