ORDER

Print the name of learned Standing Counsel Sri Dhanunjaya Naidu for respondent No.1.

Learned Assistant Government Pleader for Land Acquisition takes notice on behalf of the respondents No.2 and 3 and seeks time to get instructions in the matter.

Issue notice to the respondents No.4 to 62.

Learned counsel for the petitioners is permitted to take out personal notice on the respondents No.4 to 62 and file proof of the same.

Petitioners are challenging the proceedings dated 31.03.2026 rejecting the objection petition filed by the petitioners for payment of compensation in Sy.No.166, which acquired for the purpose of four laning of Deosugur to Jadcharla section of 167 from 181.200 km to 283.00 km., 3(D) notification and award enquiry is completed. Petitioners raised certain objections and the Revenue Divisional Officer, Narayanpet, vide impugned proceedings dated 31.03.2026 rejected the request of the petitioners as the award has already been passed vide Lr.No.F/2218/2020, dated 10.06.2023.

Learned counsel for the petitioners would submit that till date compensation has not been disbursed.

In view of the above and since the submission made by the learned counsel for the petitioners that till date compensation has not been disbursed, the respondents No.2 and 3 are directed not to disburse the compensation till 08.06.2026, if already not disbursed.

The Registry is directed to list the matter on 09.06.2026.
