Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the highhanded action of the respondents 2 to 5 at the behest of respondent No.6 in interfering with the personal life and liberty of the petitioner and in civil disputes by threatening the petitioner to cause seizure of (2) four wheeler vehicles i.e. (1) Innova Crysta vide registration No.TS-09-FU-1626 and (2) Audi Q7 vide registration No.TS-09-FY-1626 on the pretext of FIR being registered vide F.I.R.No.544 of 2024 dated 06-06-2024 on the file of 5th respondent police station despite the undertaking given in W.P.No.17530 of 2024 and W.P.No.21265 of 2024 whereby the respondent No.5 filed a Final Report closing the Crime as civil in nature and further in violation of the orders dated 09-05-2025 passed in I.A.No.535 of 2025 in O.S.No.1567 of 2025 on the file of the V Junior Civil Judge, City Civil Court, Hyderabad, the said action of the respondent police is assailed to be illegal, arbitrary and unconstitutional and contrary to law apart from being in violation of principles of natural justice and consequently direct the respondents 2 to 5 not to interfere into the

peaceful life, liberty and enjoyment of the petitioner with respect to the (2) four wheeler vehicles i.e. (1) Innova Crysta vide registration No.TS-09-FU-1626 and (2) Audi Q7 vide registration No.TS-09-FY-1626 on the pretext of FIR being registered vide F.I.R.No.544 of 2024 dated 06-06-2024.
