WHEREAS the Petitioner above named through his Advocate SRI T VASANTHA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, CERTIORARI calling for the records pertaining to the proceedings in M.C.No. A/03/2026, dated 28/02/2026 on the file of 3rd respondent herein whereby and where under the 3rd respondent invoked the provisions under Sec. 165 of BNSS,2023 pertaining to the agricultural land admeasuring Ac.0.07 1/2 guntas situated in Sy.No.99 of Pinjaramadugu Village, Kamepalli Mandal, Khammam District and set aside the same by duly declaring it as illegal, arbitrary, without jurisdiction and contrary to the provisions of BNSS-2023 apart from being violative of articles of 14, 17, 18, 21 and 300-A of Constitution of India besides violative of principles of natural justice and further direct the official respondents to pay costs and compensation.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. T VASANTHA RAO Advocate for the Petitioner and Mr. M.Srinivas, Assistant Government Pleader for Home for

respondent Nos.1 to 4, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.

Issue notice, including personal notice to respondent No.5.

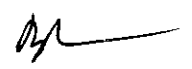
