The presence of the petitioner/accused No.2 in C.C.No.452 of 2025 on the file of the Judicial First Class Magistrate at Parigi, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner is required, he shall appear before the trial Court. In case of his non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
