WHEREAS the Petitioner above named through his Advocate Sri. KARUNAKAR presented this writ petition under Article 226 of the Constitution of India praying that in the circumstances stated in the Affidavit filed herein, the High Court may be pleased to issue an appropriate Writ, order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondent No. 2 in proposing to lay the road through the petitioner's house plot admeasuring 351 Sq. Yards in Sy.No.281/E/1 situated at Damsalapuram village, within Khammam Municipal Corporation area, Khammam District, without following the procedure contemplated under the Statute, inspite of the written representation dt. 30-4-2019 followed by personal visits, as being illegal, arbitrary and unjust, and consequently direct the 2nd respondent herein not to take any steps to lay the road through the above said plot without following due process of Law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. KARUNAKAR REDDY, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this writ petition should not be admitted in the circumstances set out in the petition and the affidavit filed in Writ Petition;
