Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order, writ or direction more particularly one in the nature of writ of Mandamus declaring the proceedings vide order No.B/1250/2001, dated 08.02.2002 passed by 4th respondent-Tahsildar, in respect of land admeasuring Ac.2.07 guntas viz. Ac.0.29 guntas in survey No.176/16/AA Ac.0.29 guntas in survey No.176/16/E and Ac.0.29 guntas in survey No.176/16/EE, situated in Aziz Nagar village, Moinabad Mandal, Ranga Reddy district, belonging to petitioners 1 and 2, and the land admeasuring Ac.0.30 guntas bearing survey No.176/16/A situated in Aziz Nagar village, Moinabad Mandal, Ranga Reddy district, belonging to petitioner No.3, as illegal, arbitrary, without jurisdiction, null and void and contrary to the provisions of the Act 9 of 1977 and violative of Articles 14, 21 and 300A of the Constitution of India, besides being violative of principles of natural justice, and consequently set aside the same and direct the respondents not to interfere with the possession of the petitioners 1 and 2 in respect of land admeasuring Ac.2.07 guntas viz. Ac.0.29 guntas in survey No.176/16/4,4 Ac.0.29 guntas in survey No.176/16/E

and Ac.0.29 guntas in survey No.176/16/EE, situated in Aziz Nagar village, Moinabad Mandal, Ranga Reddy district, and of petitioner No.3 in respect of land admeasuring Ac.0.30 guntas bearing survey No.176/16/, situated in Aziz Nagar village, Moinabad mandal, Ranga Reddy District, without following due procedure Contemplated under law, in the interest of justice and pass.

ORDER

Mr. E. Madan Mohan Rao, learned Senior Counsel appearing for Mr.D. Raghunandana Rao, learned counsel for the petitioners submitted that in similar circumstances, this Court passed an interim order, dated 17.03.2026, in W.P.No.8255 of 2026 and prayed to grant similar relief in favour of the petitioners herein.

Hence, *status quo* obtaining as on today shall be maintained in respect of the subject land till the next date of hearing.
