WHEREAS the Petitioner above named through her Advocate Sri BALA MURALI Y presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ order or direction especially one in the Nature of Writ of Mandamus declaring the action of the respondents 2 to 4, particularly the 4th respondent calling the petitioners to the police station and threatening them to settle the dispute with the 5th respondent pending suit OS No.62 of 2023 on the file of senior civil judge at karimnagar. on the instigation of 5th respondent with regard to civil dispute pending between the petitioner and 5th respondent in OS No.62 of 2023 on the file of Addl. senior civil judge at Karimnagar is illegal, arbitrary, unjust, unconstitutional, against the principles of natural justice and consequently direct the respondents 2 to 4 particularly the 4th respondent not to interfere with the civil dispute pending between the petitioner and 5th respondent without following due procedure of law and without any right and authority in entertaining the complaint of the plaintiff in OS No. 62 of 2023 on the file of Addl. senior civil judge at Karimnagar by calling the petitioner to the 4th respondent police station without following due process of law

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri BALA MURALI Y Advocate for the

Petitioner, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
