India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of . Mandamus or any other appropriate Writ, Order or Direction, directing the Respondent Nos. 2 to 5 for not considering representation dated 21.11.2025 submitted by petitioner to shift the 33KV HT Electric Line passing over the residential plots and houses of the petitioners situated in Survey Nos. 303, 304 and 305, Laxmi Nagar Colony, Rajampet, Town-II, Sangareddy District, to the PWD road side, as per the approved estimate (HT Ref. No. HT56250675) and Work Order Application MDK No. 2969, without further delay and consequently direct the Respondent Nos. 2 to 5 to consider the representation submitted by the petitioner dated 21.11.2025 for shifting a 33KV High Tension (HT) electric line that passes dangerously over the residential plots and houses of all the petitioners situated in Survey Nos. 303, 304 and 305, Laxmi Nagar Colony, Rajampet, Sangareddy Town-II, Sangareddy District to complete the aforesaid shifting work within a time-bound period to be fixed by this Hon'ble Court.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI KASIREDDY MOHAN CHANDRA HAS Advocate for the Petitioner, directed issue of notice to the Respondents No. 6 to 9 herein to show cause as to why this WRIT PETITION should not be admitted.

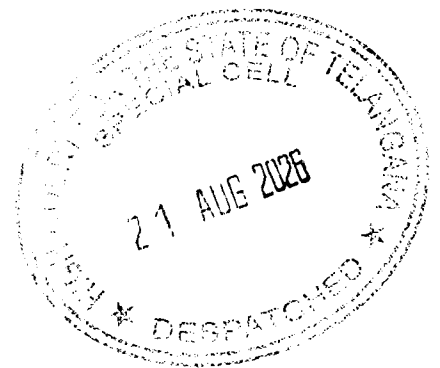
