For filing written instructions, list the matter on 17.06.2025.

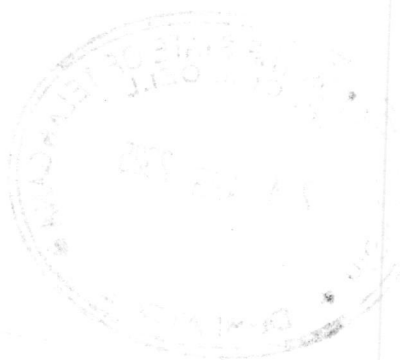
