WHEREAS the Petitioners above named through their Advocate SRI HARI KISHAN KUDIKALA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the respondents 2 to 3 on the representation dt.20-03-2026 made by the petitioner, in not taking action against the respondents 4 to 14, for their illegal construction of a house into the petitioner's open land an extent of Ac.0.39 guntas in Survey No.190/A, situated at Hasanparthy Village, Hasanparthy Mandal, Hanumakonda District, and not taking any action for removing/stop/demolish the illegal construction by the respondents 4 to 14, as illegal, arbitrary, and violative of principles of Natural Justice and also Violative of Article 14, 19 and 21 of the Constitution of India and contrary to the provisions of the Telangana Municipalities Act, and Rules, consequently direct the respondents 2 to 3 to take appropriate action to remove/stop/demolish the illegal construction made by Respondents 4 to 14 into the petitioner's open land an extent of Ac.0.39 guntas in Survey No.190/A, situated at Hasanparthy Village, Hasanparthy Mandal, Hanumakonda District, by considering the representation made by the petitioner dt.20-03-2026, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. HARI KISHAN KUDIKALA Advocate for the Petitioners, Government Pleader for MAUD for the respondents No.1 and 3 and Sri Pasham Mohith standing Counsel for the respondent No.2, directed issue of notice to the Respondent Nos. 4 to 14, here n to show cause as to why this WRIT PETITION should not be admitted.
