Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ or Writs, Order or Direction, declaring the proceedings dated 6.11.2025 in Lr. No. E1/4470/2024 issued by the 2nd Respondent, in so far as including the petitioners property admeasuring Ac. 9.05 guntas in Sy. No. 626/ 2 of Shamshabad Village and Mandal, Ranga Reddy District in the prohibitory list of properties, as illegal, arbitrary and without jurisdiction and consequently direct the 4th Respondent to forthwith receive, register and release the document presented by the petitioner in respect of land admeasuring 400 sq. yds. forming part of Sy. No. 626/2 of Shamshabad Village and Mandal, Ranga Reddy District without reference to the proceedings dated 6.11.2025 in Lr. No. E1/4470/2024 issued by the 2nd Respondent Award costs.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be

pleased to issue interim directions to the 4th Respondent to forthwith receive, register and release the document presented by the petitioner in respect of land admeasuring 400 sq. yds. forming part of Sy. No. 626/2 of Shamshabad Village and Mandal, Ranga Reddy District without reference to the proceedings dated 6.11.2025 in Lr. No. E1/4470/2024 issued by the 2nd Respondent, pending disposal of WP No 11282 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI N Sreedhar Reddy Advocate for the Petitioner, GP FOR REVENUE General (Stamps and Registration) for the Respondents, the Court made the following.

Registry is directed not to take out notice to respondent in view of the above waiver.

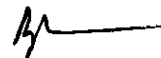
