Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ or Writs, Order or Orders one in the nature of Writ of certiorari questioning the orders Dated 11.11.2025 in Case No.F3/817/2018, passed by the Respondent No.3, wherein upheld the orders passed by the respondent No.4 in file No. C/366- 1/2018 to C/366-6/2018, all dated 28.02.2018 is illegal, arbitrary, in violation of Articles 14, 21 and 300-A of the Constitution of India and principles of Natural Justice and consequently to set-aside the orders passed by respondent No.3 in case No.F3/817/2018, dated 11.11.2025, proceedings file No.C/366-5/2018, dated 28.02.2018 passed by the respondent No.4 and proceedings No. B/2596/2017-6, dated 02.01.2018 passed by respondent No.5.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to Direct Respondents not to interfere with the possession of the petitioner in land admeasuring Ac.0-25 Gts in Sy.No.159/1A5 and Ac.0-25 Gts in

Sy.No.159/A5, total admeasuring Ac.1.10 Gts, situated at Zaheerabad Village and Mandal, Sangareddy District, pending disposal of WP No 12244 of 2026, on the file of the High Court.
