WHEREAS the Petitioner above named through his Advocate Sri S M SAIFULLAH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue and writ, order or direction more particularly one in the nature of writ of Mandamus under Article 226 of Constitution of India declaring the action of the respondents in interfering with the Civil Disputesi.e. in respect of the land in Sy.No. 793/U, adm.Ac.5-23 gts, and Sy.No.803/a, Adm.4-15 gts situated at Gongulur Village, Pulkal Mandal, Sangareddy District as illegal, arbitrary, unconstitutional and consequently direct the respondent authorities not to interfere in the civil disputes on the basis alleged lease deed in the interest of justice and equity. ✓

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri S M SAIFULLAH Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents herein not to interfere in the civil disputes with respect to the land of the petitioner in Sy.No. 793/U, adm.Ac.5-23 gts, and Sy.No.803/a, Adm.4-15 gts situated at Gongulur Village, Pulkal Mandal, Sangareddy District, pending disposal of WP No. 12319 of 2024, on the file of the High Court.

The Court made the following: ORDER

Issue notice to respondent No.4.

Learned counsel for the petitioner is permitted to take our personal notice to respondent No.4 by Registered Post with Acknowledgment Due and file proof of service by next date of hearing.

Respondent No.3 - The Station House Officer, Pulkal Police Station, is directed not to interfere in the civil disputes between the petitioner and respondent No.4 in connection with the land admeasuring Acs.5-23 guntas in Sy.No.793/U and Acs.4-15 guntas in Sy.No.803/a situated at Gongulur Village, Pulkal Mandal, Sanga Reddy District, without following due process of law.

However, it is made clear that this order shall not have any bearing on the disputes regarding the title and possession of the aforesaid land between the petitioner and respondent No.4.
