Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order, or Direction, more particularly one in the nature of a Writ of Mandamus, declaring the Election notification R.C.No.01/2026/HYD City ECHBS/Elections dated 02-04-2026, issued by the Respondent authorities for conducting elections to the Managing Committee of the Respondent No. 3 Society, as being illegal, arbitrary, unjust, and violative of the provisions of the Telangana Cooperative Societies Act, 1964, and the Article 14,20 of Constitution of India and also against the Principles of natural justice and consequently, direct the RespondentNos.3 and 5 to first undertake a thorough revision and purification of the voter list by deleting the names of ineligible persons, deceased members, and non-members, and by incorporating the photographs of all eligible voters, in strict

accordance with the law and the by-laws of the Society, before issuing a fresh notification for elections,

Heard the learned counsel appearing on behalf of the petitioner.

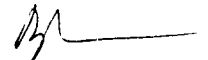
