Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the respondents Nos. 2 to 7 in not demolishing /mark for demolition of the petitioner property House No. 2-66/6, to an extent of Ac. 0.36 guntas of the property in Sy No. 148/A, situated at Ilapur Village, Ameenpur Mandal, Sanga Reddy District is illegal, arbitrary, violation of principles of natural justice, fundamental rights guaranteed under the Constitution of India, contrary to the evidence on record and as well as the provisions of The Hyderabad Disaster Response and Asset Protection Agency Act and consequently direct the respondents Nos. 2 to 7 not to demolish / mark for demolish and not to interfere the petitioner house property No. 2-66/6, to an extent of Ac. 0.36 guntas of the property in Sy No. 148/A, situated at Ilapur Village, Ameenpur Mandal, Sanga Reddy District.
