Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more in the nature of Mandamus, declaring the action of the Respondent Nos.4 to 6 in interfering with the petitioner's possession over the land admeasuring Ac.14-00 gts in Sy. No.119/AA/2 situated at Gattumalla Village, Laxmidevipalle Mandal, Bhadradi Kothagudem District, with the instigation of Respondent No.7 to 9 under the guise of survey as illegal, improper, unjust, arbitrary and violative of Articles 21, 300-A of Constitution of India and consequently direct the respondent nos. 4 to 6 not to interfere with the petitioner's land forthwith.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent no.4 to 6 not to interfere with the petitioner's lands admeasuring Ac.14-00 gts in Sy.No.119/AA/2 situated at Gattumalla Village, Laxmidevipalle Mandal, Bhadradri Kothagudem District, forthwith, pending disposal of WP No 11356 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the grounds filed in support thereof and upon hearing the arguments of Sri V.Yadu Krishna Sainath, Advocate for the Petitioner, Government Pleader For Revenue for the Respondent Nos.1 to 5 and Government Pleader for Home for the Respondent No.6, the Court made the following.

ORDER:

Heard learned counsel for the petitioner and learned Assistant Government Pleader for Revenue.

Petitioner claims to be owner of the subject land on the strength of pattadar passbook bearing No.T27160040325.

In view of the above, there shall be interim direction to the respondents not to interfere with the possession and enjoyment of the petitioner in respect of the land admeasuring Acs.14-00 guntas in Sy.No.119/AA/2 situated at Gattumalla Village, Laxmidevipalle Mandal, Bhadradri Kothagudem District, without following due process of law.
