Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of writ of mandamus or any other appropriate writ declaring the action of the respondent authorities in not allotting the paddy to the petitioner rice mill for Rabi 2024 -25 season considering the representation of the petitioner dated 08/09-04-2025, as allotting to the other rice mills in Hanumakonda District, is nothing but arbitrary, illegal, null and void and violative of principles of natural justice and also violative of Articles 14, 19 and 21 of the Constitution of India. Consequently direct the respondent authorities to allot the CMR paddy to the petitioner rice mill for Rabi 2024-25 Season, considering the representation submitted by the petitioner dated 08/09-04-2025.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent authorities to allot the CMR paddy to the petitioner rice mill for Rabi 2024-25 Season, considering the representation submitted by the petitioner dated 08/09-04-2025.

WRIT PETITION No.11949 of 2025

ORDER:

This Writ Petition is filed seeking a direction to the respondents to consider the representation of the petitioner dated 08/09.04.2025 for allotment of the paddy in its favour for the Rabi 2024-25 season as is done to other rice mills in Hanumakonda District.

2. Learned Government Pleader for Civil Supplies, appearing for the respondents, submitted that the petitioner is a defaulter, as it has not supplied stock within the stipulated period and as per the guidelines issued in G.O.Ms.No.27, dated 29.10.2024, the defaulted rice mills are not eligible for allotment of paddy.

3. Learned counsel for the petitioner, however, submitted that the petitioner is not a defaulter and it has supplied 100% of custom milled rice, particularly in view of the direction of this Court in W.P.No.14139 of 2021. Learned counsel for the petitioner further submitted that the petitioner is willing to abide by the guidelines issued in G.O.Ms.No.27, dated 29.10.2024.

4. In view of the above submissions, this Court deems it fit and proper to direct the respondents to consider the representation of the petitioner dated 08/09.04.2025 and call for any other information, if required, and allot paddy to the petitioner in accordance with G.O.Ms.No.27, CA, F&CS Department, dated 29.10.2024.

5. With the above directions, this Writ Petition is disposed of. There shall be no order as to costs.

6. Miscellaneous applications, if any, pending in this writ petition, shall stand closed.

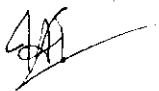
