WHEREAS the Petitioner above named through her Advocate SRI. MOHAMMED MASOOD ALI presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be please to quash the proceedings in C.C No. 5133/2020, for the offence's u/s 498-A,406,506 IPC & Section 4 & 6 of DP Act of Pending on the file of XV Addl. Chief Metropolitan Magistrate, Hyderabad herein.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. MOHAMMED MASOOD ALI Advocate for the Petitioner, and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 16.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to stay all further proceedings including appearance of the petitioner/ Accused No.3 in pursuance of in C.C No. 5133 of 2020, for the offence's u/s 498-A,406, 506 IPC and Section 4 & 6 of DP Act, pending disposal of the main Criminal Petition.

The Court made the following:

ORDER

Learned counsel for the petitioner submitted that the petitioner has not committed the alleged offences and have been falsely implicated in the present case. Even according to the allegations made in the complaint and in the final report, the offences punishable under Sections 498-A, 406 and 506 of the Indian Penal Code, 1860 and Sections 4 and 6 of the Dowry Prohibition Act, 1961 are not attracted against the petitioner. He further submitted that accused No.5 had approached this Court by filing Crl.P.No.5948 of 2022 seeking to quash the very same proceedings in C.C.No.5133 of 2020, and the same was allowed on 29.04.2024. Therefore, the petitioner is entitled to the very same benefit, as the very same allegations have been levelled against him.

Taking into consideration the above submissions, this Court is of the view that detailed examination is required for adjudication of the case.

Notice before admission.

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Post on 16.06.2026.

Till then, there shall be an interim stay of all further proceedings against the petitioner/accused No.3 in C.C.No.5133 of 2020 on the file of the XV Additional Chief Metropolitan Magistrate at Hyderabad.

In default of filing proof of service, the stay shall stand vacated.
