ORDER:

Issue notice to respondent Nos.4 to 9.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.4 to 9 by Speed Post with Acknowledgment Due and file proof of service by the next date of hearing.

Learned Assistant Government Pleader for Revenue seeks time to get instructions.

There shall be interim direction to respondent Nos.2 and 3 to consider the representation of the petitioners dated 17.03.2026 not to issue legal heir certificate to respondent Nos.4 to 9, and pass orders, in accordance with law, by issuing notice to the petitioners, respondent Nos.4 to 9, and all other concerned/interested persons, by affording opportunity of hearing to them, within a period of four (4) weeks from the date of receipt of a copy of this order.
