Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct Respondent Nos. 2 to 4 to forthwith stop all illegal construction activities over the petitioners' lands in Sy. No. 628, situated at Madharam Village, Urkonda Mandal, Nagarkurnool District, pending disposal of WP No 11959 of 2026, on the file of the High Court.

**The Court made the following:
ORDER**

Issue notice to respondent Nos.5 to 25.

Learned counsel for the petitioners is permitted to take out personal notice to respondent Nos.5 to 25 and file proof of service by the next date of hearing.

Learned Assistant Government Pleader for Revenue placed written instructions before this Court and submitted that official record supports the case of the petitioners and exposes fraudulent nature of subsequent entries and transactions. The authorities, upon due consideration of the documentary evidence and the representation dated 31.03.2026 submitted by the petitioners, found merit for cancellation of the succession proceedings issued in favour of unofficial respondents and steps are being taken to set aside such illegal succession in accordance with law.

In view of the above written instructions, as it is clear that unofficial respondents are not having any right over the subject land and the succession proceedings are stated to be fraudulent and considering the grievance of the petitioners that there are unauthorized constructions being made over the land in Survey No.628 of Madharam Village, Urkonda Mandal, Nagarkurnool District, there shall be interim direction to respondent Nos.3 and 4 to forthwith stop unauthorized constructions in Survey No.628 of Madharam Village, Urkonda Mandal, Nagarkurnool District.
