WHEREAS the Petitioners above named through their Advocate SRI NARESH KALERU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order, or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action/inaction of Respondents 2 to 4 in not protecting the government land and stopping the illegal construction undertaken by Respondents 5 and 6 over Block No. 149 in Survey No. 129 of Narsapur, Siddipet, Siddipet District, as illegal, arbitrary, contrary to law,

violative of the principles of natural justice, and inviolation of Articles 14, 21, and 300A of the Constitution of India consequently direct the respondent No. 2 to 4 to remove the illegal construction undertaken by the respondent No.5 and 6 over the Block No. 149 in Survey No. 129 of Narsapur, Siddipet, Siddipet District, and protect the land.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI NARESH KALERU Advocate for the Petitioners, AGP FOR MUNICIPAL ADMINISTRATION AND URBAN DEVELOPMENT appearing for the Respondent no.1, SRI P. KRISHNA REDDY, STANDING COUNSEL appearing for the Respondent no.2 and AGP FOR REVENUE appearing for the Respondents no. 3 and 4 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Learned counsel for the petitioners is permitted to take out personal notice on respondent Nos.5 and 6 through speed post with acknowledgment due (SPAD) and file proof of the same.

Learned Standing Counsel for GHMC submits that similar pattas were given to the unofficial respondents and seeks time to ascertain whether the constructions are currently being carried on.

Meanwhile, the respondent authorities shall consider the representation dated 18.03.2026 submitted by the petitioners and conduct spot inspection on the alleged constructions made on the subject lands.
