M A K MUKHEED presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the Respondents No.2 and 3 not cancelling the Deed of Conveyance vide Application No.APLHYD150313000879, File No.E/07/99/2015, Doc.No.2732/ 2016 dated 31.05.2016 executed and registered in favour of the Respondent No.4 in respect of house property bearing No.8-1-402/364, situated at Gulshan Colony, Tolichowki, Shaikpet, Hyderabad, during pendency of O.S.No.154 of 2013 pending before the Honble III Additional District Judge, City Civil Court at Hyderabad, without verifying the records as illegal, arbitrary, high handness and against the principles of natural justice and violation of Article 14, 16, 21, 300A of the Constitution of India, and consequently direct the Respondents No.2 & 3 to cancel the Deed of Conveyance vide Application No.APLHYD150313000879, File No.E/07/99/2015, Doc.No.2732/ 2016 dated 31.05.2016 executed and registered in favour of the Respondent No.4 in respect of house property bearing No.8-1-402/364, situated at Gulshan Colony, Tolichowki, Shaikpet, Hyderabad,

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. M A K MUKHEED Advocate for the Petitioner, directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.
