WHEREAS the Petitioner above named through his Advocate Sri B BALAJI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction by calling for records more particularly one in the nature of Writ of Certiorari, declaring proceedings in EP. No.1063 of 2025 in ARB/CF. No.646 of 2024 on the file of Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad as null and void consequently direct the respondents neither to withhold nor to deduct the salaries of the petitioner by setting aside the orders of Salary Attachment Warrant dated 23-12-2025 in EP. No.1063 of 2025 on the file of Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. B BALAJI Advocate for the Petitioner and Government Pleader for Stamps and Registration for respondent Nos.1 to 3, directed issue of notice to the Respondent Nos.4 to 6 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 13.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

I.A. NO: 1 OF 2026:

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to dispense with the filing of certified copy of in EP No. 1063 of 2025 in ARB/CF. No. 646 of 2024 on the file of Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad along with the Salary Attachment Warrants dated 23.12.2025 issued by the Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad, in the above writ petition, for the time being, pending disposal of WP No 12021 of 2026, on the file of the High Court.

I.A. NO: 2 OF 2026:

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to grant stay of all proceedings in EP No. 1063 of 2025 in ARB/CF. No. 646 of 2024 on the file of Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad along with the Salary Attachment Warrants dated 23.12.2025 issued by the Court of the VII Junior Civil Judge, City Civil Court, at Hyderabad, pending disposal of WP No 12021 of 2026, on the file of the High Court.

The Court made the following:

ORDER:

Notice before Admission.

Learned Government Pleader for Stamps and Registration takes notice on behalf of respondent Nos.1 to 3, waives further notice and seeks time to file counter-affidavit.

Registry is directed not to take out further notice to respondent Nos.1 to 3, in view of the above waiver.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.4 through speed post with acknowledgment due and file proof of service in the Registry by the next date of hearing.

Learned counsel for the petitioner submits that the Division Bench of this Court, in *Punyamuthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others* [reported in 2017 (3) ALD 387], held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award of the Deputy Registrar of Chit Funds, if presented by the decree-holder. However, in the instant case, respondent No.4 straight away filed E.P. before learned VII Junior Civil Judge, City Civil Court, Hyderabad. Therefore, learned counsel seeks indulgence of this Court.

In view of the above submission and the decision referred above, there shall be an interim stay as prayed for, insofar as the petitioner is concerned.

Post this matter on 13.07.2026 for counter-affidavit.
