WHEREAS the Petitioner above named through his Advocate Ms. D MADHAVI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or orders, direction or writ more particularly one in the nature of Writ of Certiorari.

1. Directing the Respondents 1, 2 and 4 to call for the records of Evaluation and screening committee of the CAS September 2023 conducted by Osmania University.
2. Declaring the action of the Respondent No. 1, 2 and 4 in not calling the Petitioner for an interview to extend the benefit under UGC 2006/2010 for his pending promotion during the three circulars of CAS-2019, CAS-May 2021 and CAS September 2023 as illegal, arbitrary and violative of Article 14, 19(1)(g) and 21 of the Constitution and consequently direct the Respondent No. 1, 2 and 4 to promote the petitioner under UGC 2006/2010 guidelines.
3. Direct Respondent No. 1, 2 and 4 to grant the petitioner the benefit of UGC 2006/2010 regulations as a Professor with AGP 10000 from the date of eligibility, i.e., 11.02.2018, along with all associated monetary benefits, including permitting the application of CAS September 2023 to conduct the interview, in addition to the

subsequent CAS under UGC 2006/2010 regulations, for the petitioner's pending promotion herein.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Ms. D MADHAVI Advocate for the Petitioner, Mr. Ch. Jagannadha Rao, learned Standing Counsel, takes notice on behalf of respondent Nos.1 to 5 Learned Government Pleader for Services, takes notice on behalf of respondent No.7 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
