WHEREAS the Petitioner above named through her Advocate MS. M RAJESWARI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of Mandamus, declaring action of the respondents 2 and 3 in not implementing the orders passed by the 4th respondent vide Lr.No.H/225/2026, dated 12.03.2026 for declaring the election of the 6th respondent as Sarpanch of Dhorpally Gram Panchayat, Sirpur-T Mandal, Kumaram Bheem Asifabad District as void and further action in not taking any action on the representations of the petitioner dated 04.04.2026 and 23.03.2026 for declaring the petitioner as Sarpanch of Dhorpally Gram Panchayat, Sirpur-T Mandal, Kumaram Bheem Asifabad District as highly illegal, arbitrary and in violation of Article 14 of the Constitution of India, consequently direct the respondents 2 and 3 to forthwith implement the orders passed by the 4th respondent vide Lr.No.H1225/2026, dated 12.03.2026 by declaring the election of the 6th respondent as Sarpanch of Dhorpally Gram Panchayat, Sirpur-

T Mandal, Kumaram Bheem Asifabad District as void and to declare the petitioner as Sarpanch of Dhorpally Gram Panchayat, Sirpur-T Mandal, Kumaram Bheem Asifabad District, pursuant to the representations of the petitioner dated 04.04.2026 and 23.03.2026.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of MS. M RAJESWARI Advocate for the Petitioner, Ms.Ruhi counsel representing Government Pleader for Panchayat Raj and Rural Development for respondent No.1 and Ms.Priyanka Singh Standing Counsel for respondent No.2, directed issue of notice to the Respondent Nos.3 to 6 herein to show cause as to why this WRIT PETITION should not be admitted.
