WHEREAS the Petitioner above named through her Advocate Sri. M SALEEM presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ order or direction more particularly one the nature of Writ of Mandamus or any appropriate Writ by declaring the action of the respondent authorities in not acting on the representation submitted by the petitioner dated.28-10-2025 against illegal and unauthorized encroachments made by the respondent Nos.6 to 9 and undertaking the illegal constructions raised by them in the property to an extent of 80 Sq.Yds in Sy.No.565/2 owned, possessed and allotted to the

petitioner as Beedi worker vide patta certificate No.A/3475/94, dated.24-02-1996, situated at Toopran Town, Toopran Mamdal, Medak district as illegal, arbitrary and unconstitutional and also against the Assignment laws and consequently direct the respondent authorities to take action on the representation submitted by the petitioner dated.28-10-2025 and remove the illegal and unauthorized constructs raised by the respondent Nos.6 to 9 and effect resumption of property to the petitioner in respect of 80 Sq.Yds in Sy.No.565/2 allotted to the petitioner as Beedi worker vide patta certificate No.A/3475/94, dated.24-02-1996, situated at Toopran Town.

AND WHEREAS the High Court upon perusing the petition and AFFIDAVIT filed herein and upon hearing the arguments of Sri. M SALEEM Advocate for the Petitioner and Mr. Putta Krishna Reddy, Standing Counsel for respondent No.5, directed issue of notice to the Respondent Nos.6 to 9 herein to show cause as to why this WRIT PETITION should not be admitted.

Mr. Putta Krishna Reddy, learned Standing Counsel for respondent No.5, basing on the written instructions, submitted that building permissions have been issued to respondents No.6 to 9 based on their *prima facie* title.

Learned counsel for the petitioner submitted that respondents No.6 to 9 do not have title over the subject property admeasuring 80 square yards in Survey

No.565/2, situated at Toopran Town and Mandal, Medak District, and they are assigned plots.
