Learned counsel appearing for the petitioner would submit that the petitioner has submitted a complaint dated 01.04.2026 before respondent Nos.2 to 4 regarding the illegal interference and harassment of respondent No.5, but no action has been taken on the complaint dated 01.04.2026 stated to have been submitted by the petitioner and prays this Court to direct respondent Nos.2 to 4 to take immediate action on the complaint filed by the petitioner.

This matter requires detailed examination and the facts can be ascertained only upon filing written instructions/counter by the official respondents.

In the meantime, respondent Nos.2 to 4 are directed to file a status report with regard to the complaint stated to have been filed by the petitioner and the action taken.
