RAMAA SWETHA OGIRALA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly, one in the nature of Writ of Mandamus, declaring the action of the respondent no.4 in not considering and disposing of representations dt.5-7-2025 and 31-3-2026 submitted by the petitioner seeking not to entertain any sale deed or agreement or any document for registration in respect of agriculture land to an extent of Ac.10-16 gts., in Sy.nos. 127/E.128/E/ 129. 130/E. 131/E. 132/E. 133/E. 134/E. 146/E of Chowderguda (V) Shamshabad (M) Ranga Reddy District as illegal, arbitrary, violative of principles of natural justice and consequently direct the respondent no.4 not to entertain any sale deed or agreement or any document for registration in respect of subject property.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. RAMAA SWETHA OGIRALA Advocate for the Petitioner, directed issue of fresh notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.
