Judicial Magistrate of First Class at Devarakonda against the petitioner/A-4.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. NARRI SWAMY Advocate for the Petitioner, and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 02.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be pleased to stay the docket order dt.27.11.2025 passed in CrI.M.P.No.409 of 2024 in C.C.No.1101 of 2022 on the file of Addl. Judicial Magistrate of First Class at Devarakonda against the petitioner/A-4, pending disposal of the above Criminal Petition, and proper in the interests of justice.

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

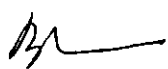
Upon perusal of the record, it reveals that, basing on the protest application filed by the State vide CrI.M.P.No.409 of 2024, the learned trial Court passed a docket order on 27.11.2025 holding that a *prima facie* case is made out against the petitioner for the offences punishable under Sections 448, 427, 323, 504, and 506 read with 34 of the Indian Penal Code, 1860. It is trite law that the learned Magistrate ought to have recorded satisfaction in respect of the offences and not against the accused.

In view of the above, the presence of the petitioner/accused No.4 in C.C.No.1101 of 2022 on the file of the Additional Judicial First Class Magistrate, Devarkonda, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner is required, he shall appear before the trial Court. In case of his non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
