WHEREAS the Petitioner above named through his Advocate Sri. A SAMIR KUMAR REDDY presented this Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to quash the CC. No. 1759 of 2024 in FIR No. 772 of 2022 dated 21.06.2023 on the file of X Addl. Metropolitan Magistrate, R.R. Dist., At Kukatpally for the offences under Sections 419, 420, 468 of IPC

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments of Sri. A SAMIR KUMAR REDDY Advocate for the Petitioner, and Additional Public Prosecutor, for the Respondent No.1 directed issue of notice to the Respondent No.2 herein to show cause as to why this CRIMINAL PETITION should not be admitted.

are directed to show cause on or before 06.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the memorandum of grounds filed therewith (copy enclosed) this CRIMINAL PETITION should not be admitted.

I.A. NO: 1 OF 2026

Petition under Section 528 of B.N.S.S. praying that in the circumstances stated in the grounds filed in support of the CRIMINAL PETITION, the High Court may be to stay of all further proceedings in CC. No. 1759 of 2024 in FIR No. 772 of 2022 dated 21.06.2023 on the file of X Addl. Metropolitan Magistrate, R.R. Dist., At Kukatpally, for the offences under Sections 419,420,468 of IPC, pending above Criminal Petition.

The Court made the following:

ORDER

Learned counsel for the petitioner submits that the trial Court, on 31.07.2024, has taken cognizance against accused Nos.1 to 10 for the offences punishable under Sections 419, 420, 467, 468, 471 read with 34 of the Indian Penal Code, 1860 and issued summons to the accused.

It is trite law that the learned trial Court ought to have taken cognizance against the offence and not against the accused by recording satisfaction and by giving reasons.

In view of the above, issue notice before admission.

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Post on 06.07.2026 in the 'adjourned motion list'.

The presence of the petitioner/accused No.4 in C.C.No.1759 of 2024 on the file of the learned X Additional Metropolitan Magistrate, Ranga Reddy at Kukatpally, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused No.4 is required, he shall appear before the

trial Court. In case of his non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
