wall bearing H.No.6-581 Rajampet Kumuram Bheem Asifabad who is having peaceful possession since more than two decades, pending disposal of WP No 12005 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI ABHILASH ASHRITH BOBBILI Advocate for the Petitioner, GP FOR REVENUE for the Respondent Nos. 1 to 4 and SRI K PRADEEP REDDY, standing Counsel for the respondent No.5, the Court made the following.

ORDER

As seen from the Ex.P5 photographs, there are structures existing on the subject property.

Hence, *status quo*, obtaining as on today, shall be maintained only in respect of the structures standing on the property bearing H.No.6-58/1, Rajampet, Komarambheem Asifabad District, till the next date of hearing.

However, this order shall not come in the way of respondent Nos.3 to 5 in taking action against the petitioner by following due process of law.
