Notice before admission.

Learned counsel for the petitioner is permitted to take out personal notice to respondent No.2 by way of Speed Post with Acknowledgment Due and file proof of service.

Post on 03.08.2026.

Learned counsel for the petitioner submits that the matter before the trial Court is not ripe for trial and is at the stage of appearance of the parties and that the petitioner is suffering from age old ailments.

In view of the same, the presence of the petitioner/accused in C.C.No.259 of 2025 on the file of the Principal Junior Civil Judge-cum-Judicial First Class Magistrate at Tandur, Vikarabad District, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of his non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
