The presence of the petitioners/accused Nos.2 to 4 in C.C.No.814 of 2025 on the file of the Principal Junior Civil Judge-cum-Judicial Magistrate of First Class, at Hanumakonda, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners is required, they shall appear before the trial Court. In case of their non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
