Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order, writ or direction more particularly one in the nature of writ of certiorari calling for records pertaining to Order vide Proc.No.ROR/2686650/2024, dated 25.10.2025 passed by respondent No.3 and declare the same as illegal, arbitrary, without jurisdiction and contrary to law, besides being violative of Articles 14, 21 and 300A of the Constitution of India, in respect of land bearing survey No.462 admeasuring Ac.25.14 guntas survey No.463 admeasuring Ac.24.17 guntas survey No.486 admeasuring Ac.20.21 guntas and survey No.487 admeasuring Ac.24.30 guntas, totally admeasuring Ac.95.03 guntas, situated in Maheshwaram village and mandal, Ranga Reddy district, in the interest of justice.

Learned senior counsel appearing for the petitioners submitted that in similar circumstances this Court passed order dated 18.02.2026 in W.P. No.5064 of 2026 and prayed to grant similar relief in favour of the petitioners herein.

Hence, there shall be interim suspension of impugned proceedings issued by respondent No.3 vide Proc.No.ROR/2686650/2024 dated 25.10.2025, until further orders.
