Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ Order or Direction more particularly one in the nature of Writ of Mandamus declaring the action of the Respondent No.2 in not legitimately protecting the interest of petitioner by duly enforcing its Circular dated 12-08-2022 vide RBI/202223/ 108 DOR ORG REC 65/21 04 158/2022-23 against Respondent Nos. 3 to 9 who are resorting to high-handed measures to recover money without following the Circular dated 12-08-2022 vide RBI/202223/ 108 DOR ORG REC 65/21 04 158/202223 issued by Respondent No. 2 and Consequently direct the Respondent Nos. 3 to 9 not to take any coercive, threatening, or adverse measures whether by visiting, calling, or through any form of communication against the Petitioner or his family members, including his wife, minor children, and elderly parents, either at their present and permanent residence or place of work, without strict adherence to the due process of law and mandatory compliance with Circular No. RBI/2022-23/ 108 DOR.ORG.REC.65/21.04.158/2022-23 issued by Respondent No. 2.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent Nos. 3 to 9 not to take any coercive, threatening, or adverse measures-whether by visiting, calling, or through any form of communication-against the Petitioner or his family members, including his wife, minor children, and elderly parents, either at their present and permanent residence or place of work, without strictly following the due process of law and ensuring mandatory compliance with Circular No. RBI/2022-23/108 DOR.ORG.REC.65/21.04.158/2022-23 issued by Respondent No. 2, pending final disposal of the present Writ Petition.

ORDER:

Heard Mr.Raghu Chadar, learned counsel for the petitioner and Smt.N.V.R.Rajya Lakshmi, learned Standing Counsel for Central Government representing Sri N.Bhujanga Rao, learned Deputy Solicitor General of India, for respondent No.1. Perused the record.

2. When the matter is taken up for hearing, learned counsel for petitioner submitted that the issue raised in this Writ Petition is squarely covered by the order passed by this Court in W.P.No.18913 of 2024, dated 22.08.2024 and therefore, the same order may be passed in this writ petition as well. The operative portion of the said order reads as under:

"8. In view of the above circulars, this Court deems it appropriate to direct the respondents to

ensure that the agents engaged by them for recovery of the loan amounts, shall strictly follow the guidelines and instructions issued by the Reserve Bank of India and also the judgments of the Hon'ble Supreme Court in **ICICI Bank Ltd Vs. Prakash Kaur's** case (1 supra) and **ICICI Bank Vs. Shanti Devi Sharma's** case (2 supra).

9. With the above direction, the writ petition is disposed of. No costs."

3. Learned Standing counsel for the respondents has no objection.

4. Accordingly, in terms of the order passed by this Court in W.P.No.18913 of 2024, dated 22.08.2024, and for the reasons alike, this writ petition is disposed of directing the respondent authorities and their agents to scrupulously follow the guidelines/instructions issued by the Reserve Bank of India in its Circular dated 12.08.2022 and also the judgments of Hon'ble Supreme Court in **ICICI Bank Ltd. v. Prakash Kaur¹** case and **ICICI Bank v. Shanti Devi Sharma²** case, while recovering the loan amounts from the petitioner. No costs.

Pending miscellaneous applications, if any, shall stand closed.
