WHEREAS the Petitioner above named through his Advocate SRI MOHAMMED RAHAIL AHMED presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction, more particularly a WRIT OF MANDAMUS declaring actions of respondents interfering with peaceful possession and not allowing the petitioner to erect fencing on the land admeasuring Ac. 0.05 Guntas, in Sy. No. 261/5/2, after NALA order, dated 13.12.2023 having Municipal Door No. 1-5-117/4/A, situated at Siddapur Village, Nirmal (U) (M), Nirmal District, as illegal, arbitrary, discriminatory, ultra vires, null and void, against the statutory powers conferred under the law, against principles of natural justice and in violation of fundamental and constitutional rights of petitioner and consequently allow the petitioner to fence the land in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. MOHAMMED RAHAIL AHMED Advocate for the Petitioner, Mr. L Ravinder, ASST GP FOR REVENUE, for the respondent Nos. 1 to 3 and Mr. Putta Krishna Reddy, standing Counsel for the respondent No.4, directed issue of notice to the Respondent Nos. 5 & 6, herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 15.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents not to interfere or attempt to dispossess the petitioner from the peaceful possession of the land admeasuring Ac. 0.05 Guntas, in Sy. No. 261/5/2, alter NALA order, dated 13.12.2023 having Municipal Door No. 1-5-117/4/A, situated at Siddapur Village, Nirmal (U) (M), Nirmal District, pending disposal of WP No 13247 of 2026, on the file of the High Court.

ORDER

Issue notice to respondent Nos.5 and 6.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.5 and 6 by Speed Post with Acknowledgment Due and file proof of service by the next date of hearing.

Heard learned counsel for the petitioner.

Mr. L. Ravinder, learned Assistant Government Pleader for Revenue, appearing for respondent Nos.1 to 3, and Mr. Putta Krishna Reddy, learned standing counsel for Municipalities, for respondent No.4, seeks time to get instructions.

Petitioner claims to be pattadar and possessor of the land admeasuring Ac.0-05 guntas in Survey No.261/5/2 situated at Siddapur Village, Nirmal Urban

Mandal, Nirmal District, on the strength of e-pattadar pass book bearing No.T14140040245 with Khata No.60229.

Hence, there shall be interim direction to respondent Nos.2 to 4 not to interfere with the peaceful possession and enjoyment of the petitioner over the land admeasuring Ac.0-05 guntas in Survey No.261/5/2 situated at Siddapur Village, Nirmal Urban Mandal, Nirmal District, without following due process of law.
