WHEREAS the Petitioner above named through her Advocate SRI N SREENIVASA YADAV presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ or order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No.4 in not recording petitioner's name under Pouthi in the Bhu Bharathi Portal by deleting petitioner's father name in the revenue records by lock Bhu Bharathi Portal as the petitioner having legal title over the land in Sy.No.617/A to an extent of Ac.0.22 gts situated at Vennempally Village, V. Saidapur Mandal, Karimnagar District is legally, arbitrary and in violation of Articles 14, 16 and 21 of the Constitution of India and consequently direct the respondent No.4 to record the name of the petitioner under Pouthi Application in place of petitioner's father with regard to land in Sy.No.617/A to an extent of Ac.0.22 gts situated at Vennempally Village, V.Saidapur Mandal, Karimnagar District.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. N SREENIVASA YADAV Advocate for the Petitioner, ASST GP FOR REVENUE, for the respondent Nos. 1 to 4, directed issue of notice to the Respondent No.5, herein to show cause as to why this WRIT PETITION should not be admitted.
