WHEREAS the Petitioners above named through their Advocate Sri AJAY KUMAR MADISETTY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus, declaring the action of the 2nd respondent in passing the impugned Order dated 02.04.2026 vide Proc No. A1 / OS/06/2024 by appointing the unofficial respondents no.4 to 12 as outsourcing agencies for the academic year from April 2026 to March 2027 basing on the Tender Notification dated 18.08.2024 against the said notification, a writ petition is pending before the Hon'ble High Court in WP No. 17333 of 2025, without issuing the fresh tender notification for the academic year 2026-2027, appointed the unofficial respondents 4 to 12 basing on the previous tender notification dated 18.08.2024 which was seized by this Hon'ble Court, knowing the same, the 2nd respondent issued the impugned order dated 02.04.2026 is highly illegal, arbitrary and against the principles of natural justice and also violative of Articles 14,19,21 and 300-A of Constitution of India by setting aside the impugned Order dated 02.04.2026 along with Lr No. A1/Outsourcing/06/2026 dated 15.04.2026 issued by the 3rd respondent and consequently direct the 2nd respondent not to proceed any further appointment of outsourcing agencies for the academic years until finalization and outcome of the writ petitions and without issuing any fresh notification for the academic year 2026-2027 pending before the Honble High Court, in the interest justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. AJAY KUMAR MADISETTY Advocate for the Petitioners, directed issue of notice to the Respondent Nos.4 to 12 to show cause as to why this WRIT PETITION should not be admitted.
