WHEREAS the Petitioners above named through their Advocate SRI PRAVEEN GOUD S presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of Writ of Mandamus Respondents Nos. 2 to 5 in not considering and acting upon the representations dated 24/02/2026, 19/02/2026 and 11/02/2026 submitted by the Petitioner No. 1 and not providing police protection and taking steps for initiating bind-over proceedings, despite Petitioner No. 1 is holding a subsisting decree of Perpetual Injunction in O.S. No. 108 of 2009 and multiple FIRs having been registered against Respondent No s. 6 to 15, who continue to commit acts of trespass, dump debris on the Petitioner No.1's property, and threaten Petitioner No. 1 to withdraw the criminal cases, as being arbitrary, illegal and in violation of Articles 14, 21 and 300- A of the Constitution of India and consequently direct Respondent Nos. 2 to 5 to provide adequate police protection and to take appropriate steps for initiating bind-over proceedings.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. PRAVEEN GOUD S Advocate for the Petitioner and Assistant Government Pleader for Home for respondent Nos.1 to 5, directed issue of notice to the Respondent Nos.6 to 15 herein to show cause as to why this WRIT PETITION should not be admitted.
