ORDER

Mr. Jithender Rao Veeramalla, learned Additional Public Prosecutor submitted that this Court has heard similar matters, namely Crl.P.No.2809 of 2026 and batch and has reserved the same for orders.

Learned counsel for the petitioner submitted that this Court, in Crl.P.No.2809 of 2026 and batch, based on the submissions made by the learned Public Prosecutor, granted protection by directing the concerned Police of the district not to take any coercive steps against the petitioners therein till passing of appropriate orders and prayed that the very same protection may be extended to the petitioner in the present criminal petition.

Learned Additional Public Prosecutor has not disputed the said submission.

In view of the order dated 05.03.2025 passed in Crl.P.No.2809 of 2026 and batch, the concerned Police of the District are directed not to take any coercive steps against the petitioner in the present criminal petition till passing of appropriate orders.

Accordingly, the present criminal petition is reserved for orders and post along with Crl.P.No.2809 of 2026 and batch.
