WHEREAS the Petitioners above named through their Advocate Mr. THAKUR RISHAB DEV SINGH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ Order or direction more particularly one in the nature of Writ of Mandamus by declaring the action of Respondent No.3 in interfering with the Petitioners personal life and liberty and Petitioners agricultural land and threatening the Petitioners to settle the dispute with the unofficial Respondent without jurisdiction as illegal arbitrary unreasonable and violate of provisions of Articles 14 300-A of the Constitution of India

consequently direct the Respondent No.3 not to interfere with the Petitioners personal life and liberty and Petitioners agricultural lands.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mr. Ravinder Reddy counsel representing Mr. THAKUR RISHAB DEV SINGH Advocate for the Petitioners and Assistant Government Pleader for Home for respondent Nos.1 to 3, directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.

I.A. NO: 1 OF 2026:

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondent No.3 not to interfere with the Petitioners personal life and liberty and Petitioners agricultural lands pending disposal of WP No 12125 of 2026, on the file of the High Court.

ORDER:

Notice before admission.

Learned Assistant Government Pleader for Home takes notice on behalf of respondent Nos.1 to 3 and waives further notice. He seeks time to obtain instructions and make submissions.

Issue notice to respondent No.4.

Personal notice is permitted.

Mr. Ravinder Reddy, learned counsel representing learned counsel for the petitioners submits that without there being any registration of crime against the petitioners, respondent No.3 is interfering with the *inter se* private civil disputes between the petitioners and respondent No.4. Therefore, he seeks to pass appropriate orders.

This matter requires detailed examination.

The facts can be ascertained only upon filing counter by respondents.

Meanwhile, respondent No.3 is directed not to interfere with the personal life and liberty of the petitioners except by following the procedure contemplated under law.
