Smt.Manjari S.Ganu, learned counsel appearing for the respondent submits that the order of *status quo* has been violated by the appellant and that the appellant is interfering with the possession and enjoyment by violating the orders of this Court.

On the other hand, learned counsel for the appellant denies the same.

Interim order granted earlier shall stand extended till the next date of hearing.

It is made clear that any violation of the interim order granted by this Court by either of the party will be taken serious note of it.
