WHEREAS the Petitioner above named through his Advocate Sri V RAVICHANDRAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus by declaring the action of the Respondents in withdrawing Petitioner's services vide impugned Rc. No. Supdt./64/Review Petition/2021 dated 19-03-2025 issued by the 6th Respondent while continuing services of other Community Organizers against whom similar allegations are leveled that too, by placing on correspondence subsequent to

Petitioner's submission of explanation to the show cause notice as being arbitrary, illegal, erroneous, opposed to principles of natural justice, discriminatory and in violation of Article 14 of the Constitution of India and to set-aside the same accordingly and further be pleased to hold that the Petitioner is entitled to be reinstated into service as Community Organizer on the analogy of orders issued by the 6th Respondent in respect of similarly situated individuals facing similar allegations with benefits incidental thereto in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit/memorandum of grounds filed herein and upon hearing the arguments of Sri V RAVICHANDRAN Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
