WHEREAS the Petitioners above named through their Advocate SRI V. VAMSI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may

be pleased to issue a writ, more particularly in the nature of a mandamus, declaring the inaction of the official Respondents in not removing the illegal gates, compound wall and barricades erected across the public road and open spaces including park spaces, within Silpa Brindavan Layout which unlawfully restrict the free movement of the Petitioners, villagers etc thereby denying ingress and egress in pursuance of the speaking orders passed by it vide UC No. 1702/TPS/C-51/KPZ/CMC/2026, dated 09-03-2026 as being illegal, arbitrary, violative of principles of natural justice and violative of petitioners, fundamental rights under Article 14, 19 and 21 of the Constitution of India and consequently direct the Respondents to remove the gates, compound wall and barricades illegally erected across the public roads and open spaces including park spaces within Silpa Brindavan Layout.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI. V VAMSI Advocate for the Petitioner, Government Pleader for MA&UD for respondent No.1, Sri.K.Ravi Mahender, standing counsel for GHMC for respondent Nos.2, 4 and 5, Sri.S.Koustubh, counsel appearing on behalf of Sri.R.Sameer Ahmed, standing counsel for HYDRAA, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
