WHEREAS the Petitioner above named through his Advocate Mr. LINGAMPALLY VENUGOPAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ order or directions more particularly one in the nature of Writ of Mandamus declaring the action of the respondent no. 1 to 7 in processing the application of the respondent no. 8 seeking financial assistance under 2 BHK Dignity Housing Scheme and the new Indiramma Indlu Scheme in respect of property H.No.16-2- 751/5/1, adm. 305.00 Square Yards, situated at Karan Bagh, Saidabad, Hyderabad (falsely claimed as H.no 16-2-751/A/1, showing extent 107 sq yards at Karan Bagh, Saidabad Colony, Hyderabad) despite objections taken by the petitioner and intimation regarding pendency of the civil suit vide O.S. No. 348/2025 on the file of IX Addl Chief Judge, City Civil Court, Hyderabad, as illegal, arbitrary and in violation of principles of natural justice, in violation of the criteria under the Indiramma Indlu Telangana Scheme 2026, and unconstitutional. Consequently, this Court may be pleased to direct the respondents no. 1 to 7 to conduct a thorough enquiry relating to eligibility criteria of the respondent No. 8 to avail the benefits under the Indiramma Indlu Telangana Scheme 2026, in respect of H. No.16-2-751/5/1, 305.00 Square Yards, situated at Karan Bagh, Saidabad, Hyderabad, (falsely claimed as 16-2-751/A/1 showing extent 107 sq yards) pending disposal of the present writ petition.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mr. LINGAMPALLY VENUGOPAL Advocate for the Petitioner and Mr. Reparti Venkatesh, Standing Counsel for GHMC, for respondent Nos.4, 5 and 7; Mr. M. Kiran Reddy, Standing Counsel for Telangana Housing Corporation Limited, for respondent No.3; and the Government Pleader for Assignment for respondent Nos.1, 2 and 6, directed issue of notice to the Respondent Nos. 8 to 14 herein to show cause as to why this WRIT PETITION should not be admitted.
