WHEREAS the Petitioner above named through his Advocate SRI MD ABUBAKER BIN AHMED presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ of Mandamus declaring the action of Respondent No.3 in interfering with the civil dispute as illegal and unconstitutional and direct Respondent No.3 not to interfere in the civil dispute between the Petitioner and private parties further more direct Respondent No.3 not to summon the Petitioner repeatedly to the police station without due process of law and Declare the acts of illegal interference and coercion as violative of Articles 21 and 22 and against personal life and liberty.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. MD ABUBAKER BIN AHMED

Advocate for the Petitioner, ASST GP FOR HOME, for the respondent Nos. 1 to 3, directed issue of notice to the Respondent No.4, herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 06.07.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct Respondent No.3 not to summon the Petitioner repeatedly to the police station without due process of law and Declare the acts of illegal interference and coercion as violative of Articles 21 and 22 and against personal life and liberty, pending disposal of WP No 13238 of 2026, on the file of the High Court.

The Court made the following:

ORDER

Notice before admission.

Learned Assistant Government Pleader for Home, takes notice for respondent Nos.1 to 3, waives further notice and seeks time to obtain instructions.

Learned counsel for the petitioner is permitted to take out personal notice on respondent No.4 through Speed Post with Acknowledgment Due and file proof of service in the Registry by the next date of hearing.

Learned counsel for the petitioner submits that the petitioner is a student, who is facing hardship and suffering at the hands of respondent No.3, who is interfering with the civil disputes between the petitioner and respondent No.4.

The matter requires detailed examination and the said aspects can only be ascertained after filing counter-affidavit by the official respondents.

In the meanwhile, as an interim measure, respondent No.3 is directed not to interfere with the *inter se* private disputes between the petitioner and respondent No.4, except in accordance with due process of law.
