Nrupender Reddy, as reflected in the revenue records prior to the illegal mutation in respect of the said land.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. OMAR A PASHA Advocate for

the Petitioner and Assistant Government Pleader for Revenue for respondent Nos.1 to 4, directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.
